A: CALL TO ORDER

A1: Ascertainment of Quorum 9:00 a.m.

A motion was made by Mr. Shannon and seconded by Mr. Onion to approve/accept (1); the minutes of the November 7, 2023 Business Committee Meeting; (2) the minutes of the November 27, 2023 Education Committee Meeting; (3) the minutes of the August 22, 2023 Advisory Committee on Education Savings Meeting; (4) the minutes of the November 16, 2023 Board Meeting. The motion was approved by a vote of 9 in favor 0 opposed, and 0 abstentions.

B: CHAIR'S REPORT 9:45 a.m.

Mr. Trafton stated the Escalation Policy is still under review.

Mr. Mello informed the board that the 2024 Board of Directors Meeting schedule has been finalized. He stated that only 3 in-person meetings will occur in 2024, in February, May, and October. He also informed the board that there will be a 2-day retreat in October.

Mr. Onion gave a business committee update stating that the committee had recommended approval of the loan request from Saddleback. Mr. Onion also stated that he had to recuse himself from voting as he has personal investments in the business.

C: ACTION ITEMS 9:52 a.m.

C1: Approval of Loan Request (Economic Recovery Loan Program)- Saddleback

Ms. Getchell presented a request for readvance (re-borrow funds already repaid) of \$500,000 on Saddleback already existing \$1 million FAME Direct Loan and \$313,000 on its 2 existing MRDA loans; The readvances would increase respective loan balances to close to their original amounts with existing maturities, loan payments and collateral would remain as they currently are, apart from adding a lien on the new equipment the FAME loan would fund.

A motion to approve the Resolution approving Loan Request was made by Ms. Hoffman, seconded by Mr. Tracy and approved by a vote of 8 in favor, 0 opposed, and 1 abstentions.

Mr. Fritz recused himself from the vote due to his personal investments in the business.

C2: Approval of Direct Loan Interest Rate Waiver 10:02 a.m.

Ms. Cummings proposed an extension of the 8% ceiling through 3/31/2024 and further recommendation that the CEO be given the authority to further extend the waiver until 6/30/2024 in his discretion.

A motion to approve the Resolution extending the Interest Rate waiver was made by Mr. Beck, seconded by Mr. Fritz and approved by a vote of 9 in favor, 0 opposed, and 0 abstentions.

C3: Approval of Rule Adoption: Chapter 612, Amendment 5 - Maine Dental Education Loan and Loan Repayment Program 10:15 a.m.

Mr. Roney proposed Rule Adoption for Chapter 612, Amendment 5 -Maine Dental Education Loan and Loan Repayment Program. The approval of this rule change would allow a change in terminology from "Expected Family Contribution" or "EFC" to "Student Aid Index" or "SAI" following changes at the federal level as part of simplification of the Free Application for Federal Student Aid (FAFSA).

Mr. Roney proposed the approval of the Chapter 618, Amendment 3 Maine Veterinary Medicine Loan Program. The approval of this rule change would allow a change in terminology from "Expected Family Contribution" or "EFC" to "Student Aid Index" or "SAI" following changes at the federal level as part of simplification of the Free Application for Federal Student Aid (FAFSA).

A motion to approve adoption of the rule amendment was made by Mr. Onion, seconded by Mr. Tracy and approved by a vote of 10 in favor, 0 opposed, and 0 abstention.

C6: Approval of NextGen 529 Modification to Terms and Conditions of Maine Grant Programs 10:23 a.m.

Ms. Giles requested the FAME Board to approve modifications to Terms and Conditions of Maine Grant Programs to become effective January 1, 2024 and the anticipated disclosure update for July 1, 2024.

A motion to approve the modification to NextGen's Terms and Conditions was made by Mr. Beck, seconded by Ms. Shannon and approved by a vote of 10 in favor, 0 opposed, and 0 abstentions.

Mr. Mello shared an update on FAME's Thrive grant program, Grow Maine, and shared updates on FAME's NextGen program. He also shared that Showcase Maine was a success.

D2: Maximum Contribution Recommendation

Ms. Giles notified the board that the Chief Executive Officer, Carlos Mello had approved an increase in the maximum total contribution in a NextGen 529 account to \$545,000 from \$520,000.
