- **1.** Be a current or former participant in a FAME program (Commercial Loan Insurance Program, Economic Recovery Loan Program, Maine Seed Capital Tax Credit Program, or Bond Programs) within the last three years and provide quality employment.
- **2.** Have made a positive impact on Maine's economy through advancement of natural resource utilization (e.g., forest products, agriculture, fisheries, etc.), emerging industries (e.g., biotech, software, engineered applications, etc.), or other demonstrable positive economic activity.
- **3.** Works within the commercial lending or economic development community and exemplifies a history of successfully leveraging resources by providing assistance to businesses in the state of Maine.
