Decide Who Will Start the FAFSA

The FAFSA is a *Roles-Based* form

Student Section



Either student or parent can start the FAFSA and they will **"invite"** the other to complete the FAFSA.

The invite is what connects the student and parent sections of the FAFSA.

Parent Section





For today's walk through, the student starts the FAFSA.





- If student is not logged into StudentAid.gov, they'll be taken to the Log In screen.
- Link to retrieve username and to reset password.
- If no account can click on "Create Account."
- When logging in, people required to confirm contact information.
